**RE: THE APPLICATION OF SAMSON  
LONE STAR, L.P. TO SUSPEND THE  
ALLOCATION FORMULA IN THE  
TRAWICK (PETTIT) FIELD,  
NACOGDOCHES COUNTY, TEXAS**

**FINAL ORDER**

After statutory notice in the above-numbered docket heard on July 11, 2007, the Railroad Commission of Texas makes the following findings of fact and conclusions of law:

**FINDINGS OF FACT**

1. Notice of at least ten (10) days was given to all operators in the field and no one appeared at the hearing in protest.
2. The Trawick (Pettit) Field is a non-associated field which was discovered in 1962. There are three operators and 42 wells in the field.
3. There is no evidence that all operators of producing wells in the subject field do not have 100% market demand for the gas produced from wells under their control.
  - a. Reservoir capability since January 2006 has ranged from 93 MMCF per month to 232 MMCF per month.
  - b. Production as a percent of capability for the field has averaged 114% since January 2006.
  - c. Well statuses range from 29 MMCF under to 283 MMCF over.
  - d. The field has been balanced several times since 1999 to correct fluctuations in assigned allowables.
4. Suspension of the allocation formula in the Trawick (Pettit) Field will not cause a pipeline limitation.

**CONCLUSIONS OF LAW**

1. Proper notice was issued by the Railroad Commission of Texas to persons legally entitled to notice.

2. All things have been done and occurred to give the Railroad Commission of Texas jurisdiction to decide this matter.
3. The subject field meets all the criteria established for suspension of the allocation formula under Statewide Rule 31(j).

Therefore, it is ORDERED by the Railroad Commission of Texas that the application of Samson Lone Star, L.P. for suspension of the allocation formula in the Trawick (Pettit) Field is approved. The allocation formula may be reinstated administratively if the market demand for gas in the Trawick (Pettit) Field drops below 100% of deliverability. If the market demand for gas in the Trawick (Pettit) Field drops below 100% of deliverability while the allocation formula is suspended, the operator shall immediately notify the Commission and the allocation formula shall be immediately reinstated.

For so long as the allocation formula for this field remains suspended, operators shall not be required to submit a plat when filing Form P-15 for wells completed in this field; provided, however, that operators are required to submit for each well completed in this field a Form P-15, without a plat, stating the amount of acres assigned to the well for proration purposes.
