ENFORCEMENT ACTION FOR ALLEGED VIOLATIONS COMMITTED BY DONNA M. DAVIS D/B/A DELANEY OIL AND GAS COMPANY (210850), AS TO THE JUNIOR WHITE LEASE, WELL NO. 1 (129667), VIRGINIA FRANCES (CROSS CUT) FIELD, COLEMAN COUNTY, TEXAS

FINAL ORDER

The Commission finds that after statutory notice the captioned enforcement proceeding was heard by the examiner on December 13, 1999 and that the respondent, Donna M. Davis d/b/a Delaney Oil and Gas Company (210850), failed to appear or respond to the notice. Pursuant to § 1.49 of the Commission's General Rules of Practice and Procedure [Tex. R. R. Comm'n, 16 TEX. ADMIN. CODE § 1.49] and after being duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas, the Commission makes the following findings of fact and conclusions of law.

FINDINGS OF FACT

- 1. Donna M. Davis d/b/a Delaney Oil and Gas Company (210850), ("respondent") was given Notice of Opportunity for Hearing by certified mail, addressed to the most recent P-5 address on the Form P-5 (Organization Report) address, which was returned to the Commission marked "unclaimed."
- 2. The returned certified receipt containing the Original Complaint and the Notice of Hearing Opportunity, was returned to the Commission marked "unclaimed" on November 30, 1999. The certified receipt has been on file with the Commission for 15 days, exclusive of the day of receipt and day of issuance.
- 3. Respondent designated itself to the Commission as the operator of Well No. 1 (129667) on the Junior White Lease ("subject well"/subject lease") by filing a Form P-4 (Producer's Transportation Authority and Certificate of Compliance), effective on May 1, 1994.
- The subject well has been dry or inactive for a period in excess of one year. Commission inspection and/or production reports indicate that the subject well ceased production on or before July 31, 1997.
- 5. The subject well was not properly plugged in a timely manner, in accordance with, and was not otherwise in compliance with, Statewide Rule 14.
- 6. Usable quality water in the area could have been contaminated by migrations or discharges

of saltwater and other oil and gas wastes from the subject well. Unplugged wellbores constitute a cognizable threat to public health and safety because of the probability of pollution.

- 7. The estimated cost to the State of plugging all of the subject well was \$5,600.00.
- 8. Richardson Resources, Inc. (708778) became the new P-4 operator for the Junior White Lease, Well No. 1 (129667), effective on November 19, 1999.
- 9. Commission district office inspection reports indicate that Richardson Resources, Inc. (708778), brought the Junior White Lease, Well No. 1 (129667) into compliance on or before December 8, 1999.
- 10. The respondent did not demonstrate good faith since it failed to plug or otherwise place the subject well and subject lease in compliance after being notified of the violations by the District Office and failed to appear at the hearing to explain its inaction.

CONCLUSIONS OF LAW

- 1. Proper notice was issued by the Railroad Commission to respondent and all other appropriate persons legally entitled to notice.
- 2. All things necessary to the Commission attaining jurisdiction over the subject matter and the parties in this hearing have been performed or have occurred.
- 3. Respondent was in violation of Commission Statewide Rule 14(b)(2).
- 4. Respondent was responsible for maintaining the subject well and the subject lease in compliance with all applicable Statutes and Commission rules, specifically Statewide Rules 14, 58, and 79 and Chapters 89 and 91, Texas Natural Resources Code.
- 5. The documented violations committed by the respondent constitute acts deemed serious, a hazard to the public health, and demonstrate a lack of good faith pursuant to Tex. Nat. Res. Code Ann. §81.0531(c) (Vernon 1993).

IT IS ORDERED THAT within 30 days from the day immediately following the date this order becomes final:

1. Donna M. Davis d/b/a Delaney Oil and Gas Company (210850), shall pay to the Railroad Commission of Texas, for disposition as provided by law, an administrative penalty in the amount of **THREE THOUSAND DOLLARS (\$3,000.00)**.

It is further **ORDERED** by the Commission that this order shall not be final and effective until

20 days after a party is notified of the Commission's order. A party is presumed to have been notified of the Commission's order three days after the date on which the notice is actually mailed. If a timely motion for rehearing is filed by any party at interest, this order shall not become final and effective until such motion is overruled, or if such motion is granted, this order shall be subject to further action by the Commission. Pursuant to Tex. Gov't Code § 2001.146(e), the time allotted for Commission action on a motion for rehearing in this case prior to its being overruled by operation of law, is hereby extended until 90 days from the date the order is served on the parties.

All requested findings of fact and conclusions of law which are not expressly adopted herein are denied. All pending motions and requests for relief not previously granted or granted herein are denied.

Noncompliance with the provisions of this order is subject to enforcement by the Attorney General and subject to civil penalties of up to \$10,000.00 per day per violation.
