FINAL ORDER CONSIDERING A MOST EFFICIENT RATE ALLOWABLE AND INCREASED NET GAS-OIL RATIO AUTHORITY FOR VARIOUS LEASES, GOLDSMITH (CLEAR FORK) FIELD, ECTOR COUNTY, TEXAS

The Commission finds that after statutory notice in the above-numbered docket heard on May 15, 2013, the presiding examiner has made and filed a report and recommendation containing findings of fact and conclusions of law, for which service was not required; that the proposed application is in compliance with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the examiner's report and recommendation, the findings of fact and conclusions of law contained therein, hereby adopts as its own the findings of fact and conclusions of law contained therein, and incorporates said findings of fact and conclusions of law as if fully set out and separately stated herein.

Therefore, it is **ORDERED** by the Railroad Commission of Texas that the 22 wells listed on Attachment A in the Goldsmith (Clear Fork) Field, Ector County, Texas, may be produced under a Maximum Efficient Rate allowable of 500 BOPD with a daily gas limit of 1.000 MCFGPD.

It is further **ORDERED** that the 22 wells listed on Attachment A in the Goldsmith (Clear Fork) Field, Ector County, Texas, are exempt from Statewide Rule 49(a).

It is further **ORDERED** that all accumulated overproduction for these wells is canceled.
