## FINAL ORDER APPROVING THE APPLICATION OF CLAYTON WILLIAMS ENERGY, INC. FOR EXCEPTION TO STATEWIDE RULE 32 FOR VARIOUS LEASES SPRABERRY (TREND AREA) FIELD

ANDREWS COUNTY, TEXAS

The Commission finds that after statutory notice in the above-numbered docket heard on April 24, 2013, the presiding examiners have made and filed a report and recommendation containing findings of fact and conclusions of law, for which service was not required; that the proposed application is in compliance with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the examiners' report and proposal for decision, the findings of fact and conclusions of law contained therein, and any exceptions and replies thereto, hereby adopts as its own the findings of fact and conclusions of law contained therein, and incorporates said findings of fact and conclusions of law as if fully set out and separately stated herein.

Therefore, it is **ORDERED** by the Railroad Commission of Texas that Clayton Williams Energy, Inc. is hereby granted an exception to Statewide Rule 32 for the flare points identified on Exhibit A attached hereto, Spraberry (Trend Area) Field, Andrews County, Texas. Clayton Williams Energy, Inc. is authorized to flare or vent a cumulative total of up to 2.5 MMCFPD of casinghead gas from various leases from April 24, 2013, through December 31, 2013, from any combination of flare points identified on Exhibit A. The authority is granted, provided all production is reported on the appropriate Commission forms.

The operator shall file the Statewide Rule 32 Exception Data Sheet for each flare point identified on Exhibit A and, shall file at the same time, the appropriate Commission required administrative Statewide Rule 32 Exception gas flaring fee; provided, however, that each Statewide Rule 32 Exception Data Sheet need not reflect volumes of gas to be flared or vented at the flare point identified, but instead the operator shall attach a copy of this final order, including Exhibit A.
