FINAL ORDER
APPROVING THE APPLICATION OF
ENERGEN RESOURCES CORPORATION
FOR EXCEPTION TO STATEWIDE RULE 32 FOR
NORTH ROBERTSON UNIT LEASE N. ROBERTSON
(CLEAR FORK 7100) FIELD GAINES COUNTY, TEXAS
AND THE MILT YATER, MC NEW 28 AND MC NEW 28A LEASES
SPRABERRY (TREND AREA) FIELD MARTIN COUNTY, TEXAS

The Commission finds that after statutory notice in the above-numbered docket heard on June 27, 2014, the presiding examiners have made and filed a report and recommendation containing findings of fact and conclusions of law, for which service was not required; that the proposed application is in compliance with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the examiners' report and proposal for decision, the findings of fact and conclusions of law contained therein, and any exceptions and replies thereto, hereby adopts as its own the findings of fact and conclusions of law contained therein, and incorporates said findings of fact and conclusions of law as if fully set out and separately stated herein.

Therefore, it is **ORDERED** by the Railroad Commission of Texas that Energen Resources Corporation, is hereby granted an exception to Statewide Rule 32 for the North Robertson Unit Lease (Lease ID No. 8A-69530), Robertson, N. (Clear Fork 7100) Field, Gaines County, Texas. Energen Resources Corporation is authorized to flare up to 700 MCF per day of casinghead gas from the North Robertson Unit Lease, from May 3, 2014 through May 2, 2016. The authority is granted, provided all production is reported on the appropriate Commission forms. The operator shall file the Statewide Rule 32 Exception Data Sheet and, shall file at the same time, the appropriate Commission required administrative Statewide Rule 32 Exception gas flaring fee.

It is further **ORDERED** by the Railroad Commission of Texas that Energen Resources Corporation, is hereby granted an exception to Statewide Rule 32 for the Milt Yater Lease (Lease ID No. 08-16504), Spraberry (Trend Area) Field, Martin County, Texas. Energen Resources Corporation is authorized to flare up to 199 MCF per day of casinghead gas from the Milt Yater Lease, from March 4, 2014 through March 3, 2016. The authority is granted, provided all production is reported on the appropriate Commission forms. The operator shall file the Statewide Rule 32 Exception Data Sheet and, shall file at the same time, the appropriate Commission required administrative Statewide Rule 32 Exception gas

flaring fee.

It is further **ORDERED** by the Railroad Commission of Texas that Energen Resources Corporation, is hereby granted an exception to Statewide Rule 32 for the McNew 28 and McNew 28A Leases, Commingling Permit No. 08-6104, Spraberry (Trend Area) Field, Martin County, Texas. Energen Resources Corporation is authorized to flare up to 155 MCF per day of casinghead gas from the McNew 28 and McNew 28A Leases (CP No. 08-6104), from May 1, 2014 through April 30, 2016. The authority is granted, provided all production is reported on the appropriate Commission forms. The operator shall file the Statewide Rule 32 Exception Data Sheet and, shall file at the same time, the appropriate Commission required administrative Statewide Rule 32 Exception gas flaring fee.
