FINAL ORDER

APPROVING THE APPLICATION CONOCOPHILLIPS COMPANY FOR AN EXCEPTION TO STATEWIDE RULE 32 FOR VARIOUS TANK BATTERIES ON THE CHALK E (41219) LEASE, CHALK G (41220) LEASE, CHALK MARY (41221) LEASE, CHALK NORTH (41243) LEASE, CHALK SOUTH (41216) LEASE, DOUTHIT (41225) LEASE, KELLY ROBERTS (41244) AND (32327) LEASES, REED (41247) LEASE AND CHALK SEC. 95 (30848) LEASE, IN THE HOWARD GLASSCOCK (CONSOLIDATED) AND HOWARD GLASSCOCK (WOLFCAMP 7400) FIELDS, HOWARD COUNTY, TEXAS.

The Commission finds that after statutory notice in the above-numbered docket heard on January 16, 2015, the presiding examiners have made and filed a report and recommendation containing findings of fact and conclusions of law, for which service was not required; that the proposed application is in compliance with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the examiners' report and proposal for decision, the findings of fact and conclusions of law contained therein, and any exceptions and replies thereto, hereby adopts as its own the findings of fact and conclusions of law contained therein, and incorporates said findings of fact and conclusions of law as if fully set out and separately stated herein.

Therefore, it is **ORDERED** by the Railroad Commission of Texas that ConocoPhillips Company is hereby granted an exception to Statewide Rule 32 for the tank batteries on the ten subject leases. From October 14, 2014 through October 14, 2015, a total of 365 days, ConocoPhillips Company is authorized to flare a total of 1,525 MCFD from the subject tank batteries and leases under Permit No. 17315.

The authority is granted, provided all production is reported on the appropriate Commission forms. The operator shall file the Statewide Rule 32 Exception Data Sheet and, shall file at the same time, the appropriate Commission required administrative Statewide Rule 32 Exception gas flaring fee for each well.
