**FINAL ORDER  
APPROVING THE APPLICATION OF  
ATLAS EAGLE FORD OPERATING CO., LLC  
FOR EXCEPTION TO STATEWIDE RULE 32  
FOR VARIOUS TANK BATTERIES (GROUP 4)  
EAGLEVILLE (EAGLE FORD-1) FIELD  
ATASCOSA COUNTY, TEXAS**

The Commission finds that after statutory notice in the above-numbered docket heard on November 9, 2015, the presiding examiners have made and filed a report and recommendation containing findings of fact and conclusions of law, for which service was not required; that the proposed application is in compliance with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the examiners' report and recommendation, the findings of fact and conclusions of law contained therein, and any exceptions and replies thereto, hereby adopts as its own the findings of fact and conclusions of law contained therein, and incorporates said findings of fact and conclusions of law as if fully set out and separately stated herein.

Therefore, it is **ORDERED** by the Railroad Commission of Texas that Atlas Eagle Ford Operating Co., LLC is hereby granted an exception to Statewide Rule 32 for the tank batteries identified as being associated with Group 4 in Appendix A, attached herewith, Eagleville (Eagle Ford-1) Field, Atascosa County, Texas. Atlas Eagle Ford Operating Co., LLC is authorized to flare up to the maximum monthly volume specified for each tank battery identified as being associated with Group 4 in Appendix A for a period of two years, effective August 19, 2015. This authority is granted, provided all production is reported on the appropriate Commission forms.

The operator shall simultaneously file the Statewide Rule 32 Exception Data Sheet and, the appropriate Commission required administrative Statewide Rule 32 Exception gas flaring fee.
