

**MINUTES  
RAILROAD COMMISSION OF TEXAS  
FORMAL COMMISSION ACTIONS**

**December 15, 2015**

After providing notice as required by the Texas Open Meetings Act, the Railroad Commission of Texas held an open meeting at the William B. Travis Building, 1701 N. Congress Avenue, in Room 1-111, Austin, Texas, on **Tuesday, December 15, 2015** commencing at 9:33 a.m. Chairman David Porter, Commissioner Christi Craddick and Commissioner Ryan Sitton were present. Chairman Porter presided.
