FINAL ORDER

APPROVING THE APPLICATION OF CONOCOPHILLIPS COMPANY, LP, FOR AN EXCEPTION TO STATEWIDE RULE 32 FOR VARIOUS TANK BATTERIES ON THE CHALK E (41219) LEASE, CHALK G (41220) LEASE, CHALK MARY (41221) LEASE, CHALK NORTH (41243) LEASE, CHALK SOUTH (41216) LEASE, DOUTHIT (41225) LEASE, KELLY ROBERTS (41244) AND (32327) LEASES, REED (41247) LEASE AND CHALK SEC. 95 (30848) LEASE, IN THE HOWARD GLASSCOCK (CONSOLIDATED) AND HOWARD GLASSCOCK (WOLFCAMP7400) FIELDS, HOWARD COUNTY, TEXAS.

The Commission finds that after statutory notice in the above-numbered docket heard on November 05, 2015, the presiding examiners have made and filed a report and recommendation containing findings of fact and conclusions of law, for which service was not required; that the proposed application is in compliance with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the examiners' report and proposal for decision, the findings of fact and conclusions of law contained therein, and any exceptions and replies thereto, hereby adopts as its own the findings of fact and conclusions of law contained therein, and incorporates said findings of fact and conclusions of law as if fully set out and separately stated herein.

Therefore, it is **ORDERED** by the Railroad Commission of Texas ConocoPhillips Company, LP. is hereby granted an exception to Statewide Rule 32 for various tank batteries on Various Leases in the Howard Glasscock (Consolidated) and Howard Glasscock (Wolfcamp7400) Fields, Howard County, Texas. ConocoPhillips is authorized to flare 2,000 MCFD of casing head gas from the ten leases. for a period of two years from October 14, 2015 through October 14, 2017. The authority is granted, provided all production is reported on the appropriate Commission forms. The operator shall file the Statewide Rule 32 Exception Data Sheet for the Augusta Barrow Lease and shall file, at the same time the appropriate Commission required administrative Statewide Rule 32 Exception gas flaring fee.
