**ORDER NUNC PRO TUNC**

**FINAL ORDER  
APPROVING BLANKET AUTHORITY FOR  
EXCEPTION TO STATEWIDE RULE 10 FOR THE  
BRISCOE RANCH (EAGLEFORD) AND AMMANN (BUDA) FIELDS  
DIMMIT, MAVERICK AND WEBB COUNTIES, TEXAS**

In conference at its office in Austin, Texas, the Railroad Commission of Texas took up for consideration its Final Order entered on November 6, 2012, the matter approving blanket authority for exception to Statewide Rule 10 for the Briscoe Ranch (Eagleford) and Ammann (Buda) Fields, Dimmit, Maverick, and Webb Counties, Texas. The Commission finds that the Final Order entered November 6, 2012, contains a typographical error in the field name for the Ammann (Buda) Field. The nunc pro tunc order corrects this error.

Accordingly, it is **ORDERED** that the Final Order in Docket No. 01-0277305 be, and the same is hereby, amended nunc pro tunc to correct the typographical error in the field name for the Ammann (Buda) Field. The corrected final order approving blanket authority for exception to Statewide Rule 10 for the Briscoe Ranch (Eagleford) and Ammann (Buda) Fields, Dimmit, Maverick, and Webb Counties, Texas now reads as follows:

It is **ORDERED** by the Railroad Commission of Texas that blanket authority for exception to Statewide Rule 10 is hereby approved for all wells in the Briscoe Ranch (Eagleford) (Field No. 12018 200) and Ammann (Buda) (Field No. 02396 500) Fields, Dimmit, Maverick and Webb Counties, Texas.

For wells which are commingled in the subject fields after the effective date of this order, commingled production shall be assigned to the Briscoe Ranch (Eagleford) Field.

Further, acreage assigned to wells on any leases for allocation of allowable shall not be assigned to any other well or wells projected to be completed in the subject fields; such duplicate assignment of acreage is not acceptable, provided however, that this limitation shall not prevent the reformation of development or proration units so long

as no duplicate assignment of acreage occurs, and further, that such reformation does not violate other conservation regulations.

The operator of any well downhole commingled in the subject fields shall file the appropriate drilling permit, completion forms, an abbreviated Statewide Rule 10 Data Sheet for Wells Subject to Fieldwide Statewide Rule 10 exception (See Attachment A) and shall file at the same time, the appropriate Commission required administrative Statewide Rule 10 exception downhole commingling fee.
