## FINDINGS OF FACT

- 1. Proper notice of this hearing was given to all parties entitled to notice at least ten days prior to the date of hearing. There were no protests to the applications.
- 2. Tema is requesting to flare casinghead gas produced from wells completed in the Phantom (Wolfcamp), Sandbar (Bone Spring), and Grice (Wolfcamp) Fields in Loving County, Texas.
- 3. All of the subject leases in each of the applications are connected to a sales line.
- 4. Tema is requesting an exception to Statewide Rule 32 to flare casinghead gas when system upsets or pipeline capacity constraints occur.
