## **RULES AND REGULATIONS**

This Carrier will receive Propylene for intrastate transportation from the origin point named herein to destination points named herein, subject to the following Rules and Regulations:

### **Item No. 1 - Quality**

No Propylene will be accepted for shipment unless its kind and quality are the same as that being transported by the Carrier and the transportation of such Propylene will not result in any damage to the quality or characteristics of other shipments.

### **Item No. 2 - Destination Facilities Required**

Shipments will be received for transportation only when the consignor or consignee has provided the necessary facilities required to receive such shipments as they arrive at destination.

### **Item No. 3 - Gauging, Testing and Volume Corrections**

Propylene received by the Carrier for delivery may be tested by the Carrier prior to its receipt from the shipper. Quantities will be measured through meters.

Carrier shall account to each shipper for all Propylene received.

### **Item No. 4 - Payment of Transportation and Other Charges**

The shipper or consignee shall pay the transportation and all other lawful charges accruing on Propylene which has been transported and, if required, shall pay the same before delivery. Transportation charges will be collected on the basis of the net quantities delivered. Propylene accepted for transportation shall be subject to a first lien for all such charges.

### **Item No. 5 - Liens and Unpaid Charges**

When any Propylene tendered for transportation hereunder is involved in litigation, or the ownership of which may be in dispute, or which may be encumbered by lien or charge of any kind, Carrier may require of shippers an indemnity bond to protect it against all losses.

### **Item No. 6 - Liability of Carrier**

The Carrier, while in possession of any of the Propylene herein described, shall not be liable for any loss thereof, damage thereto, or delay, except to the extent that liability therefore is imposed on the Carrier by law. In case of loss of Propylene for which Carrier is not responsible, the shipper shall bear the loss.

### **Item No. 7 - Notice of Claims**

Notice of claims for loss, damage or delay in connection with shipments must be made in writing to Carrier within ninety-one (91) days after such shall have accrued, or, in case of failure to make delivery, within ninety-one (91) days after a reasonable time for delivery shall have elapsed.

### **Item No. 8 - Pumping Service**

Pumping service to move said Propylene from origin point to destination shall be furnished by the shipper.
