- (2) **DEDICATED RATE:** The joint tariff dedication rate is available to any Shipper for the transportation of crude oil produced from acreage that is dedicated, subsequent to August 1, 2012, to shipment on the pipeline pursuant to a fully executed Dedication Agreement with Hoover Energy Texas Crude LLC for a minimum of 10,000 acres for a minimum term of five years.
