## **FINAL ORDER**

GRANTING THE APPLICATION OF EP ENERGY E&P COMPANY, L. P. FOR EXCEPTIONS TO STATEWIDE RULE 32 TO FLARE GAS FROM THE BROWN CPF, STOREY ALTITO NORTHWEST CPF, HIXON CENTRAL CPF, NEWMAN CPF, WAREING CPF, STOREY ALTITO WEST CENTRAL CPF, AND THE MALTSBERGER SOUTHWEST CPF, IN THE EAGLEVILLE (EAGLE FORD-1) FIELD, LA SALLE COUNTY, TEXAS.

The Commission finds that after statutory notice in the above-numbered docket heard on December 29, 2016, the Technical Examiner and Administrative Law Judge (collectively referred to as "Examiners") have made and filed a report and recommendation containing findings of fact and conclusions of law, for which service was not required; that the proposed application by EP Energy E&P Company, L.P. is in compliance with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at a conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the Examiners' report and recommendation and the findings of fact and conclusions of law contained therein, hereby adopts as its own the findings of fact and conclusions of law contained therein and incorporates the findings of fact and conclusions of law as if fully set out and separately stated herein.

Therefore, it is **ORDERED** by the Railroad Commission of Texas that EP Energy E&P Company, L.P. is hereby granted an exception to Statewide Rule 32 for seven Central Processing Facilities, (CPFs) LaSalle County, Texas. EP Energy is hereby authorized to flare up to 5,000 cubic feet (mcf) of casinghead gas per day from the seven CPFs listed below for a period of two years.

The operator shall file the Statewide Rule 32 Exception Data Sheet and, shall file at the same time, the appropriate Commission required administrative Statewide Rule 32 Exception gas flaring fee for the facility.
