# MINUTES RAILROAD COMMISSION OF TEXAS FORMAL COMMISSION ACTIONS

#### November 15, 2016

After providing notice as required by the Texas Open Meetings Act, the Railroad Commission of Texas held an open meeting at the William B. Travis Building, 1701 N. Congress Avenue, in Room 1-111, Austin, Texas, on Tuesday, November 15, 2016 commencing at 9:30 a.m. Chairman David Porter, Commissioner Christi Craddick and Commissioner Ryan Sitton were present. Chairman Porter presided.

#### **HEARINGS DIVISION**

#### **GAS SERVICES**

- 1. The Commission unanimously approved the proposed order Nunc Pro Tunc.

The ALJ shall amend the Order to specifically describe the person or persons by whom the inspection is to be made and to issue the amended order.

The Commission unanimously approved this recommendation.

Appeal number 2 (Order granting Evergreen's Motion to Compel Responses on Polk's responses to interrogatories and request for production dated November 1, 2016). The Commission unanimously denied the appeal.

Appeal number 3 (Polk's appeal of Evergreen's motion to overrule objections to Interrogatories and production of documents as they relate to Polk's Trade Secret Objections, including the Protective Order).

The Commission unanimously approved to grant to the extent that Polk argues the current Protective Order does not reflect similar protective orders by the U.S. District Courts of Western District of Texas.

The Commission unanimously granted the appeal.
