**FINAL ORDER  
APPROVING THE APPLICATION OF  
RKI EXPLORATION & PRODUCTION LLC FOR AN EXCEPTION  
TO STATEWIDE RULE 32 FOR VARIOUS LEASES/WELLS,  
SANDBAR (BONE SPRING) FIELD,  
REEVES AND LOVING COUNTIES, TEXAS**

The Commission finds that after statutory notice in the above-numbered docket heard on December 5, 2016, the presiding Administrative Law Judge and Technical Examiner (collectively, "Examiners") have made and filed a report and recommendation containing findings of fact and conclusions of law, for which service was not required; that the proposed application is in compliance with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the Examiners' report and recommendation, the findings of fact and conclusions of law contained therein, and hereby adopts as its own the findings of fact and conclusions of law contained therein, and incorporates said findings of fact and conclusions of law as if fully set out and separately stated herein.

Therefore, it is **ORDERED** by the Railroad Commission of Texas that RKI Exploration & Production LLC is hereby granted an exception to Statewide Rule 32 for the flare points listed in Attachment A. RKI Exploration & Production LLC is authorized to flare up to the maximum monthly volume as listed in Attachment A, effective October 12, 2016 to October 11, 2018. The authority is granted, provided all production is reported on the appropriate Commission forms.

The operator shall file the Statewide Rule 32 Exception Data Sheet and, shall file at the same time, the appropriate Commission required administrative Statewide Rule 32 Exception gas flaring fee for each flare point.
