FINAL ORDER

RETURNING TO STATEWIDE RULES
FOR THE BIG MINERAL CREEK (WOODFORD) FIELD
OF GRAYSON COUNTY, TEXAS

The Commission finds that after statutory notice in the above-numbered docket reviewed on January 31, 2017, the presiding examiner has made and filed a report and recommendation containing findings of fact and conclusions of law, for which service was not required; that the proposed application is in compliance with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the examiner's report and recommendation, the findings of fact and conclusions of law contained therein, hereby adopts as its own the findings of fact and conclusions of law contained therein, and incorporates said findings of fact and conclusions of law as if fully set out and separately stated herein.

Therefore, it is ordered by the Railroad Commission of Texas that:

1. Temporary Rules adopted in Final Order No. 09-0284894, effective November 26, 2013, for the BIG MINERAL CREEK (WOODFORD) ([field number]) Field of GRAYSON County, Texas are to be RESCINDED and the field rules are to be returned to statewide.
2. The reference to temporary duration of the rules to be deleted.

BRIEF DESCRIPTION OF CASE:

This field is currently operating under temporary field rules established under Oil and Gas Docket No. 09-0271441, effective March 6, 2012, setting temporary field rules in place until February 28, 2014. On November 26, 2013, the Commission approved an order under 09-0284894 extending these temporary field rules for additional time until March 20, 2015. On December 20, 2016, the Commission issued initial notification to all operators in the field that the Commission is now considering, on its own motion, the effectiveness of these temporary field rules. On January 16, 2017, the Commission received a response from Jetta requesting to make these existing temporary field rules permanent. No relevant data could be supplied to support the field rules be kept as permanent. On January 18, 2017, the Commission received a response from Jetta requesting to continue these existing field rules as temporary for an additional period of 18 months. Since these field rules have been continued once before, and no new data was provided to support another continuation, this request could not be approved. On January 30, 2017, the Commission received a response from Jetta requesting to make these existing temporary field rules permanent. No relevant data could be supplied to support the field rules be kept as permanent. The most recent oil or gas well drilling permit issued in the field was approved in September 2016, and well was drilled and completed by Blackwell Exp & Development, LLC. There are currently 2 operators on schedule with 6 active producers. The highest oil allowable is 18 bbl/day. Current Commission records indicate that the total cumulative production through March 2017 for the field is 199,687 bbl oil and 2 MMCF gas.

EXAMINER RECOMMENDS: Temporary field rules be made rescinded.


