FINAL ORDER

APPLICATION OF TRINITY EOR, LLC FOR RAILROAD COMMISSION RECOGNITION OF THE RUTH HUDSON (69338) AS AN ENTITY FOR DENSITY IN THE GEORGE ALLEN (SAN ANDRES) (34438 500) FIELD OF GAINES COUNTY, DISTRICT 8A, TEXAS

The Commission finds that after statutory notice and staff review in the above-numbered docket reviewed on April 25, 2017 the presiding examiner has made and filed a report and recommendation containing findings of fact and conclusions of law, for which service was not required; that the proposed application is in compliance with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the examiner's report and recommendation, the findings of fact and conclusions of law contained therein, hereby adopts as its own the findings of fact and conclusions of law contained therein, and incorporates said findings of fact and conclusions of law as if fully set out and separately stated herein.

Therefore, it is ordered by the Railroad Commission of Texas that effective August 1, 2017, Trinity EOR, LLC, be granted an exception to the density and spacing rules for the Ruth Hudson (69338) in the George Allen (San Andres) (34438 500) field, Gaines County, Texas recognized said unit as an entity for density purposes subject to the following terms and conditions:

1. Wells will be drilled in compliance with the applicable lease line spacing rule unless exception is granted after notice and opportunity for hearing.
2. The unit's density shall not exceed that authorized by applicable Field Rules unless exception is granted after notice and opportunity for hearing. If required by the applicable field rules, operator shall file a Form P-15 and plat for the unit.
3. Except as otherwise provided herein, operator shall comply with all other applicable Field Rules for the George Allen (San Andres) (34438 500) Field.
