**FINAL ORDER  
GRANTING THE APPLICATION OF PDC PERMIAN, INC.  
FOR AN EXCEPTION TO STATEWIDE RULE 32 FOR MULTIPLE FACILITIES,  
PHANTOM (WOLFCAMP) FIELD,  
REEVES COUNTY, TEXAS**

The Commission finds that after statutory notice in the above-numbered docket heard on August 9, 2017, the presiding administrative law judge and technical examiner ("Examiners") have made and filed a report and recommendation containing findings of fact and conclusions of law, for which service was not required; that the proposed application complies with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the Examiners' report and recommendation, the findings of fact and conclusions of law contained therein, hereby adopts as its own the findings of fact and conclusions of law contained therein, and incorporates said findings of fact and conclusions of law as if fully set out and separately stated herein.

Therefore, it is **ORDERED** by the Railroad Commission of Texas that PDC Permian, Inc. is hereby granted authority to flare gas from the subject facilities in the Phantom (Wolfcamp) Field, Reeves County, Texas. PDC Permian, Inc. is authorized to flare according to the following schedule:

- For the Atlantis 59-10 Lease, Permit No. 29160, PDC is authorized to flare up to 15,000 mcf gas per month from July 27, 2017 through July 26, 2019.
- For the Liam State 53-12 Lease, Permit No. 28908, PDC is authorized to flare up to 1,750 mcf gas per month from August 5, 2017 through August 4, 2019.
- For the Ranger 56-40 Lease, Permit No. 29255, PDC is authorized to flare up to 3,000 mcf gas per month from September 15, 2017 through September 14, 2019.
- For the Ron 56-8 Unit, Permit No. 29161, PDC is authorized to flare up to 1,750 mcf gas per month from July 21, 2017 through July 20, 2019.
- For the Tisdale Lease, Permit No. 29159, PDC is authorized to flare up to 1,850 mcf gas per month from July 25, 2017 through July 24, 2019.

- For the Wilson Battery (Commingle Permit No. 7285), Permit No. 29155, PDC is authorized to flare up to 2,500 mcf gas per month from July 3, 2017 through July 2, 2019.

This authority is granted, provided all production is reported on the appropriate Commission forms. The operator shall file the Statewide Rule 32 Exception Data Sheet and, shall file at the same time, the appropriate Commission required administrative Statewide Rule 32 Exception gas flaring fee for the facility.

Pursuant to §2001.144(a)(4)(A), of the Texas Government Code, and the agreement of the applicant, this Final Order is effective when a Master Order relating to this Final Order is signed.
