
SINGLE SIGNATURE P-4 FILING OF ROOSTER PRODUCTION, LLC (OPERATOR NO. 727087) FOR THE HART, A. S. (00904), LEASE, WELL NO. 1, MARION COUNTY (SHALLOW) FIELD, MARION COUNTY, TEXAS, TO CHANGE THE OPERATOR FROM KIDS FUTURE, L.L.C. (OPERATOR NO. 459167) TO ROOSTER PRODUCTION, LLC

ORDER NUNC PRO TUNC

Notice of Open Meeting to consider this Order was duly posted with the Secretary of State within the time period provided by law pursuant to Tex. Gov't Code Ann. Chap, *et seq.* (Vernon 2004 & Supp. 2010). The Railroad Commission of Texas finds that, due to a clerical error, the Final Order entered on January 23, 2018 did not match the Hearings Division's Unprotested Master Order signed by the Commission, as it incorrectly included in the Caption reference to Well No. 7, adopted Finding of Fact No. 15, which incorrectly included Well No. 7, and adopted Conclusions of Law Nos. 4 and 5, which incorrectly included Well No. 7. Instead, the caption as it appears above, is how it should have appeared. Finding of Fact No. 15 should have stated: "The Hart, A. S. (00904), Lease, Well No. 1, Marion County (Shallow) Field, Marion County, Texas, should be transferred to Rooster Production as operator of record." Conclusions of Law No. 4 should have stated: "Kids Future does not have a "good faith claim" to continue to operate the Hart, A. S. (00904), Lease, Well No. 1, Marion County (Shallow) Field, Marion County, Texas." Conclusions of Law No. 5 should have stated: "Rooster Production does have a "good faith claim" to continue to operate the Hart, A. S. (00904), Lease, Well No. 1, Marion County (Shallow) Field, Marion County, Texas."

Accordingly, it is **ORDERED** that the Caption, Find of Fact No. 15, Conclusions of Law Nos. 4 and 5 contained in this Docket's Final Order issued in this proceeding is hereby amended *nunc pro tunc* to reflect that:

The Commission hereby adopts the following corrected Caption, as follows:

The Commission hereby adopts the following corrected Conclusions of Law No. 4, as follows:

Kids Future does not have a "good faith claim" to continue to operate the Hart, A. S. (00904), Lease, Well No. 1, Marion County (Shallow) Field, Marion County, Texas.

The Commission hereby adopts the following corrected Conclusions of Law No. 5, as follows:

Rooster Production does have a "good faith claim" to continue to operate the Hart, A. S. (00904), Lease, Well No. 1, Marion County (Shallow) Field, Marion County, Texas.

It is further **ORDERED** by the Commission that this order shall be final and effective on the date the original order would have been final.

All pending motions and requests for relief not previously or herein granted are denied.
