ENFORCEMENT ACTION AGAINST GAMBILL ENERGY, LLC (OPERATOR NO. 293413) FOR VIOLATIONS OF STATEWIDE RULES ON THE STRINGER, SUE (04997) LEASE, WELL NOS. 1, 2, 3, 4, 5A, 6A, 8, 9, 10, AND 12; AND THE CROW, W. E. (05154) LEASE, WELL NOS. 1, 4, 10, 11R, 12, 14, 15, 16, 17, 18, AND 19, WICHITA COUNTY REGULAR FIELD, WICHITA COUNTY, TEXAS

FINAL ORDER

The Railroad Commission of Texas ("Commission") finds that after statutory notice the captioned enforcement proceeding was heard by a Commission Administrative Law Judge on April 5, 2018, and that the respondent, Gambill Energy, LLC, failed to appear or respond to the **Notice of Opportunity for Hearing**. Pursuant to § 1.25 of the Commission's General Rules of Practice and Procedure, 16 Tex. Admin. Code § 1.25, and after being duly submitted to the Commission at a conference held in its offices in Austin, Texas, the Commission makes the following findings of fact and conclusions of law.

FINDINGS OF FACT

- 1. Gambill Energy, LLC ("Respondent"), Operator No. 293413, was sent the Original Complaint and Notice of Opportunity for Hearing by certified and first-class mail, addressed to the most recent Commission Form P-5 (Organization Report) ("Form P-5") address.
- The certified mail envelope containing the Original Complaint and Notice of Opportunity for Hearing addressed to the Respondent on E Campbell was returned to the Commission unopened on February 27, 2018. The first-class mail envelope addressed to Respondent on E Campbell was returned to the Commission on February 26, 2018. The certified mail envelope containing the Original Complaint and Notice of Opportunity for Hearing addressed to the Respondent on N Collins was returned to the Commission unopened on March 2, 2018. The first-class mail envelope addressed to Respondent on N Collins was returned to the Commission on March 1, 2018. Record of the delivery and return of certified mail has been on file with the Commission for more than 15 days, exclusive of the day of receipt and day of issuance. Respondent was given more than 30 days' notice of the Original Complaint and Notice of Opportunity for Hearing. Respondent has not entered into an agreed settlement order, filed an answer or requested a hearing.
- 3. On June 20, 2016, Respondent, a limited liability company, filed a Form P-5 with the Commission.

- 4. Respondent's Form P-5 is delinquent. Respondent had a \$50,000.00 cash deposit as its financial assurance at the time of the last Form P-5 annual renewal submission.
- 5. Respondent designated itself to the Commission as the operator of the Stringer, Sue (04997) Lease, Well Nos. 1, 2, 3, 4, 5A, 6A, 8, 9, 10, and 12, by filing a Commission Form P-4 (Certificate of Compliance and Transportation Authority), effective June 1, 2016, approved July 14, 2016.
- 6. Respondent designated itself to the Commission as the operator of the Crow, W. E. (05154) Lease, Well Nos. 1, 4, 10, 11R, 12, 14, 15, 16, 17, 18, and 19, by filing a Commission Form P-4 (Certificate of Compliance and Transportation Authority), effective June 1, 2016, approved August 23, 2016.
- 7. Commission inspection reports made on June 27, 2017 and October 17, 2017, for the Stringer, Sue (04997) Lease, Well No. 1,2 shows that the sign or identification required to be posted at the well location was missing.
- 8. Commission inspection reports made on July 5, 2017 and November 6, 2017, for the Crow, W. E. (05154) Lease, Well No. 19, shows that the sign or identification required to be posted at the well location was missing.
- 9. The lack of legible signs and identification displaying correct information, as set forth in Statewide Rule 3(2), may cause confusion as to the responsible operator to be contacted and the actual location of a violation or emergency, which can result in delays in remedying a violation or emergency.
- 10. A Commission inspection report made on July 5, 2017 for the Crow, W. E. (05154) Lease shows that Well No. 4 is leaking oil from an open valve. A follow-up inspection conducted on November 6, 2017 shows that Well No. 14 is leaking from the stuffing box and affecting a 5' x 5' area with produced water.
- 11. Respondent did not have a permit for said discharges, nor were they authorized under Statewide Rules 8(d)(3), 8(e), 9, 46 or 98.
- 12. Unpermitted discharges of oil and gas waste, in violation of Statewide Rule 8(d)(1), can contaminate the land surface, affect the health of humans and animals, and may eventually be discharged to surface or subsurface waters, causing pollution.
- 13. According to Commission records, Well No. 19 of the Crow, W. E. (05154) Lease was completed on November 10, 1980. Commission district inspection reports made on July 5, 2017 and November 6, 2017 for the Crow, W. E. (05154) Lease indicate the presence of an open completion pit located at Well No. 19 containing storm water and measuring approximately 15' x 10' x 5' deep.
- 14. Completion/workover pits used when completing or working over a well that are not maintained, emptied and backfilled, as set forth in Statewide Rule 8(d)(4)(H)(i)(III), may result in unpermitted discharges of oil and gas waste which can contaminate the land surface, affect the health of humans and animals, and may be discharged to surface or subsurface waters, causing pollution.

- 15. Commission district inspection reports made on June 27, 2017 and October 17, 2017 for the Stringer, Sue (04997) Lease show that Well No. 6A has casing open to the atmosphere.
- 16. Commission district inspection reports made on July 5, 2017 and November 6, 2017 for the Crow, W. E. (05154) Lease show that Well Nos. 17 and 19 have casing open to the atmosphere.
- 17. Wells left uncontrolled or open to the atmosphere, in violation of Statewide Rule 13(a)(6)(A), may discharge oil and gas waste onto the land surface and affect the health of humans and animals; these discharges may eventually make their way to surface or subsurface waters, causing pollution.
- 18. Commission inspection reports made on June 27, 2017 and October 17, 2017, and the absence of reported production since April 2015, showed that the Stringer, Sue (04997) Lease, Well Nos. 1, 2, 3, 4, 5A, 6A, 8, 9, 10, and 12 have been inactive for a period greater than one year. Production from the subject lease ceased on or before March 2015.
- 19. The Crow, W.E. (05154) Lease, Well No. 19 is a permitted injection well. Commission inspection reports made on July 5, 2017 and November 6, 2017, and the absence of reported production since April 2015, and the total absence of reported injection since Well No. 19 was permitted in January 2017, show that the Crow, W. E. (05154) Lease, Well Nos. 1, 4, 10, 11R, 12, 14, 15, 16, 17, 18, and 19 have been inactive for a period greater than one year. Production from the subject lease ceased on or before March 2015.
- 20. No workovers, re-entries, or subsequent operations have taken place on the subject well within the last twelve months; the subject well has not been properly plugged in accordance with Statewide Rule 14, 16 Tex. ADMIN CODE § 3.14; and no plugging extensions are in effect for the subject well as allowed by Statewide Rule 14.
- 21. Usable quality groundwater in the area can become contaminated by migrations or discharges of saltwater and other oil and gas waste from the subject well. Unplugged wellbores, in violation of Statewide Rule 14(b)(2), constitute a cognizable threat to the public health and safety because of the potential of pollution.
- 22. The total estimated cost to the State for plugging the Stringer, Sue (04997) Lease Well Nos. 1, 4, 10, 11R, 12, 14, 15, 16, 17, 18, and 19 is \$50,200.00. The total estimated cost to the State for plugging the Crow, W. E. (05154) Lease Well Nos. 1, 4, 10, 11R, 12, 14, 15, 16, 17, 18, and 19 is \$54,400.00.
- 23. The Respondent has no prior history of violations of Commission Rules.

CONCLUSIONS OF LAW

- 1. Proper notice was issued by the Commission to Respondent and all other appropriate persons legally entitled to notice.
- 2. All things necessary to the Commission attaining jurisdiction over the subject matter and the parties have been performed or have occurred.
- 3. Respondent is responsible for maintaining the subject lease in compliance with all applicable Commission rules and Tex. Nat. Res. Code, chs. 89 and 91.
- 4. Respondent is in violation of Statewide Rules 3(2), 8(d)(1), 8(d)(4)(H)(i)(III), 13(a)(6)(A), and 14(b)(2). 16 Tex. ADMIN. CODE §§ 3.3(2), 3.8(d)(1), 3.8(d)(4)(H)(i)(III), 3.13(a)(6)(A), and 3.14(b)(2).
- 5. The documented violations committed by Respondent constitute acts deemed serious, and a hazard to the public health, and demonstrate a lack of good faith pursuant to Tex. Nat. Res. Code § 81.0531(c).
- 6. Respondent is responsible for maintaining the subject leases in compliance with Statewide Rule 3(2), which requires that each well site that produces oil, gas, or geothermal resources shall post signs or identification showing the name of the property, name of the operator and the well number.
- 7. Respondent is responsible for maintaining the subject leases in compliance with Statewide Rule 8(d)(1), which prohibits the discharge of oil and gas waste without a permit.
- 8. Respondent is responsible for maintaining the subject lease in compliance with Statewide Rule 8(d)(4)(H)(i)(III), which requires a person who maintains or uses a completion or workover pit in conjunction with completing or working over a well to dewater the pit within 30 days and backfill and compact the pit within 120 days of completion of the well.
- 9. Respondent is responsible for maintaining surface control of a well by using wellhead assemblies in compliance with Statewide Rule 13(a)(6)(A). Maintenance of surface control is necessary not only to prevent fluids from being discharged from the wellbore onto the ground surface, but also to prevent any oil and gas wastes present in the wellbore from being displaced to surface by influxes of surface water into the open wellbore.

- 10. Respondent is responsible for maintaining the subject leases in compliance with Statewide Rule 14(b)(2), which requires that plugging operations on each dry or inactive well shall be commenced within a period of one year after drilling or operations cease and shall proceed with due diligence until completed, unless the operator is eligible for and obtains an extension of the plugging deadline.
- 11. Pursuant to Tex. Nat. Res. Code § 81.0531, the Commission may assess administrative penalties against Respondent for the subject violations of up to \$10,000 per day for each violation, with each day such violations continued constituting a separate violation.
- 12. An assessed administrative penalty in the amount of **EIGHTY-THREE THOUSAND DOLLARS (\$83,000.00)** is justified considering the facts and violations at issue.

ORDERING PROVISIONS

IT IS ORDERED THAT within 30 days from the day immediately following the date this order becomes final:

- 1. Gambill Energy, LLC (Operator No. 293413) shall place the Stringer, Sue (04997) Lease, Well Nos. 1, 2, 3, 4, 5A, 6A, 8, 9, 10, and 12, ; and Crow, W. E. (05154) Lease, Well Nos. 1, 4, 10, 11R, 12, 14, 15, 16, 17, 18, and 19, in compliance with Statewide Rules 3(2), 8(d)(1), 8(d)(2), 13(a)(6)(A), 14(b)(2), and 8(d)(4)(H)(i)(III), and any other applicable Commission rules and statutes.
- 2. Gambill Energy, LLC (Operator No. 293413) shall pay to the Railroad Commission of Texas, for disposition as provided by law, an administrative penalty in the amount of **EIGHTY-THREE THOUSAND DOLLARS** (\$83,000.00).

It is further **ORDERED** by the Commission that this order shall not be final and effective until 25 days after the order is signed, unless the time for filing a motion for rehearing has been extended under Tex. Gov't Code § 2001.142, by agreement under Tex. Gov't Code § 2001.147, or by written Commission order issued pursuant to Tex. Gov't Code § 2001.146(e). If a timely motion for rehearing of an application is filed by any party at interest, this order shall not become final and effective until such motion is overruled, or if such motion is granted, this order shall be subject to further action by the Commission. Pursuant to Tex. Gov't Code § 2001.146(e), the time allotted for Commission action on a motion for rehearing in this case prior to its being overruled by operation of law is hereby extended until 100 days from the date the Commission order is signed.

Noncompliance with the provisions of this order is subject to enforcement by the Attorney General and subject to civil penalties of up to \$10,000 per day per violation.
