
**SUBJECT:** Field Operations Section

September 2018, FY 2019

Attached is the monthly report titled "State-funded Well Plugging Activities" for the Field Operations Section of the Oil and Gas Division. This report contains the following:

1. Monthly and cumulative performance measure summaries of the state-funded well plugging activities of this Section.
2. Summary graphs of wells plugged, cost of wells plugged, number of salvage operations, and salvage proceeds.

The information contained in this report includes only those wells that have been physically plugged, invoiced by the plugging contractor, and approved for payment by Field Operations. Plugging operations are tracked daily to monitor the progress in meeting the FY 2019 goal of plugging 1,560 wells. As of September 30, 2018, a total of 107 wells have been physically plugged, though not all of them have yet been invoiced and approved for payment.

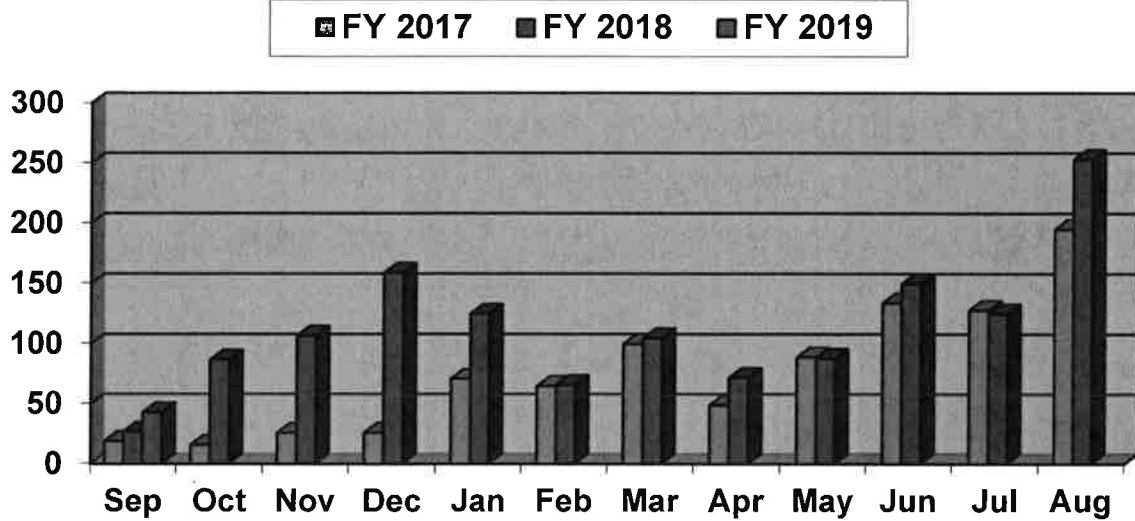

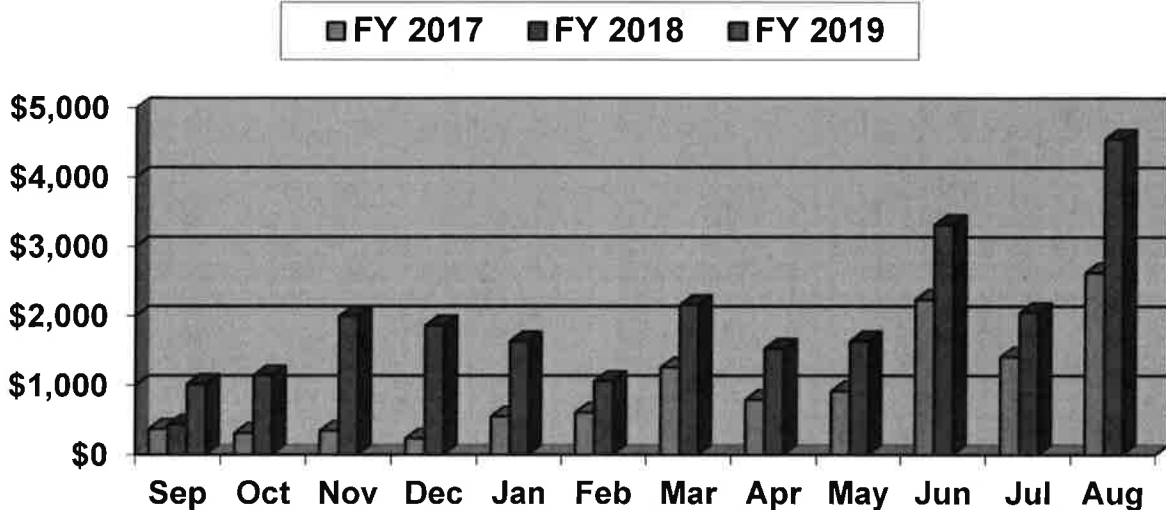

## State-funded Well Plugging Program Monthly Wells Plugged September 2018



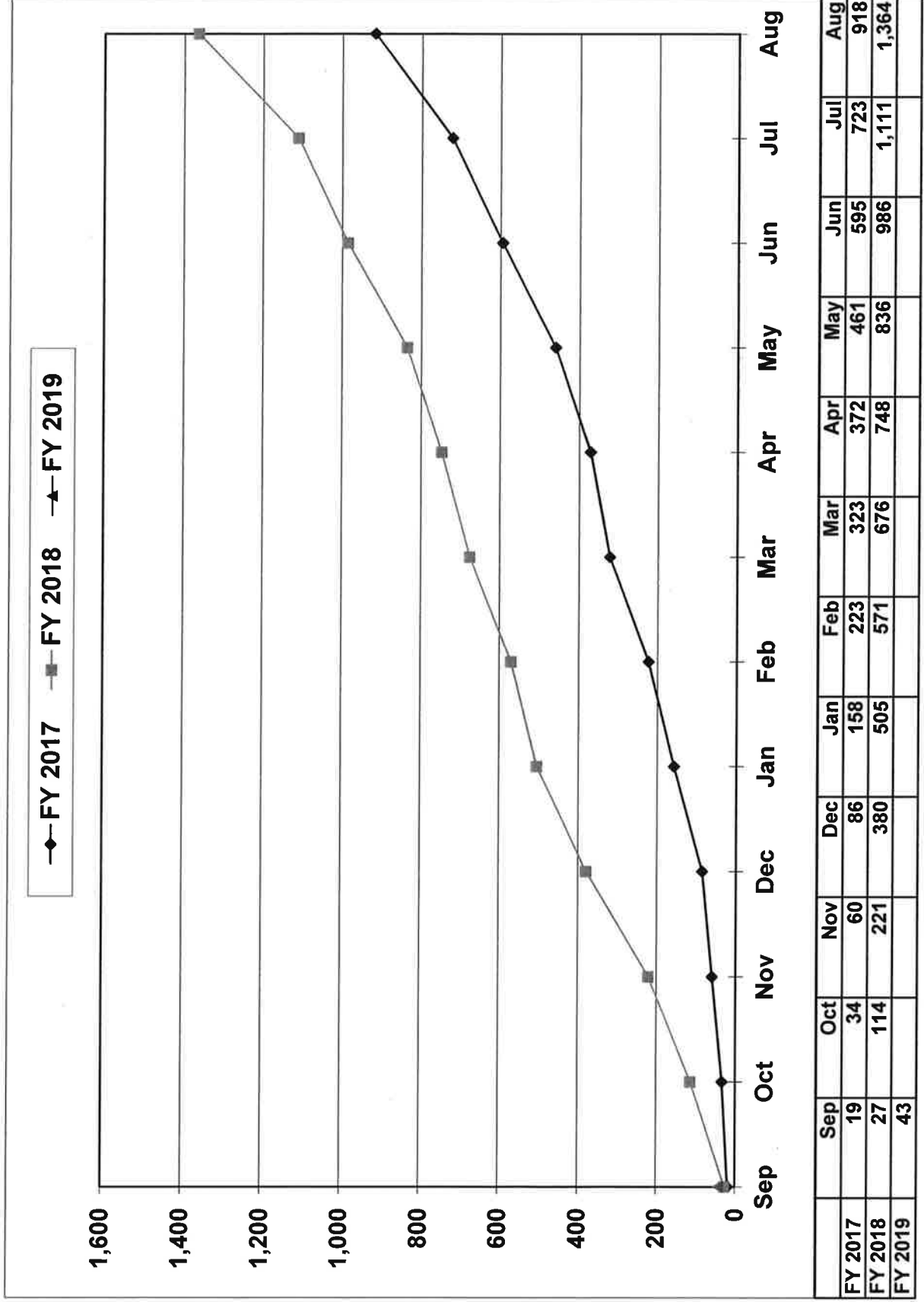

## State-funded Well Plugging Program Monthly Cost of Wells Plugged September 2018

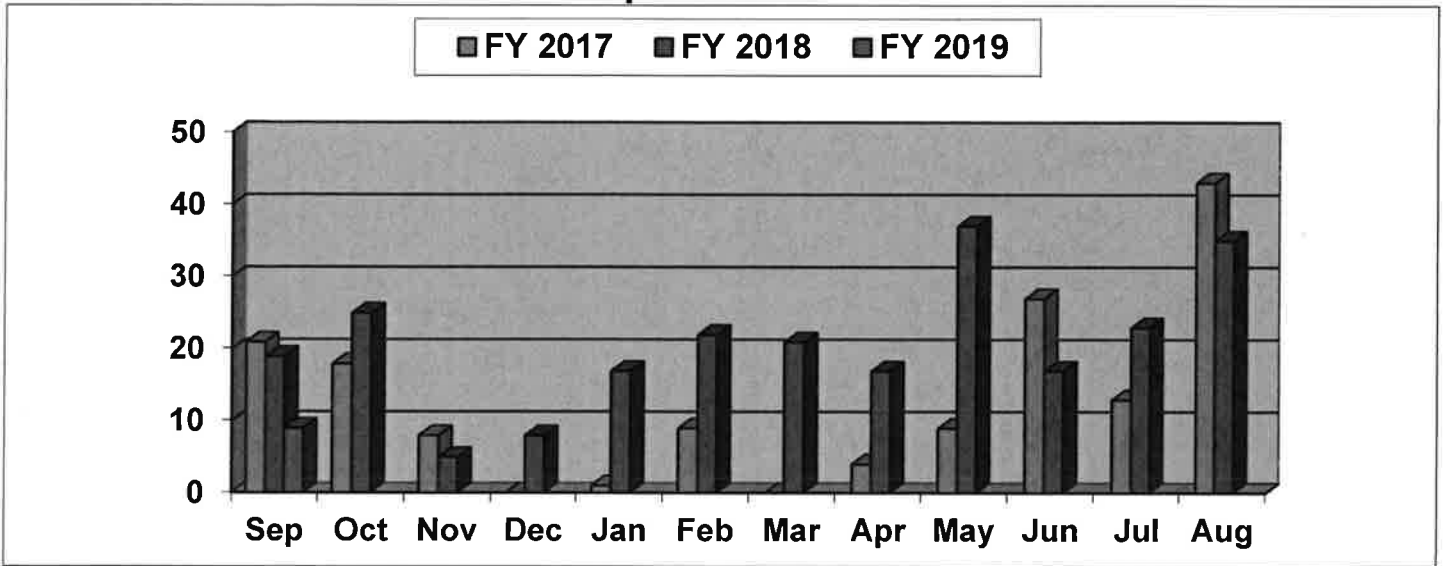

# State-funded Well Plugging Program Cumulative Wells Plugged September 2018

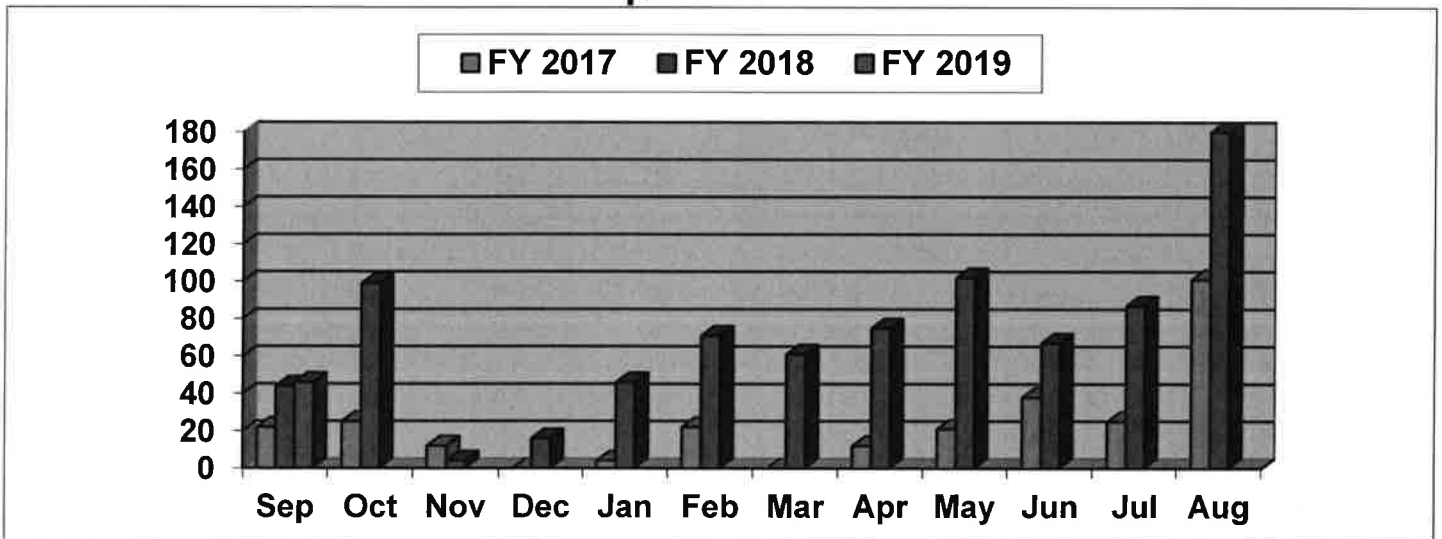


## State-funded Well Plugging Program Monthly Salvage Operations September 2018



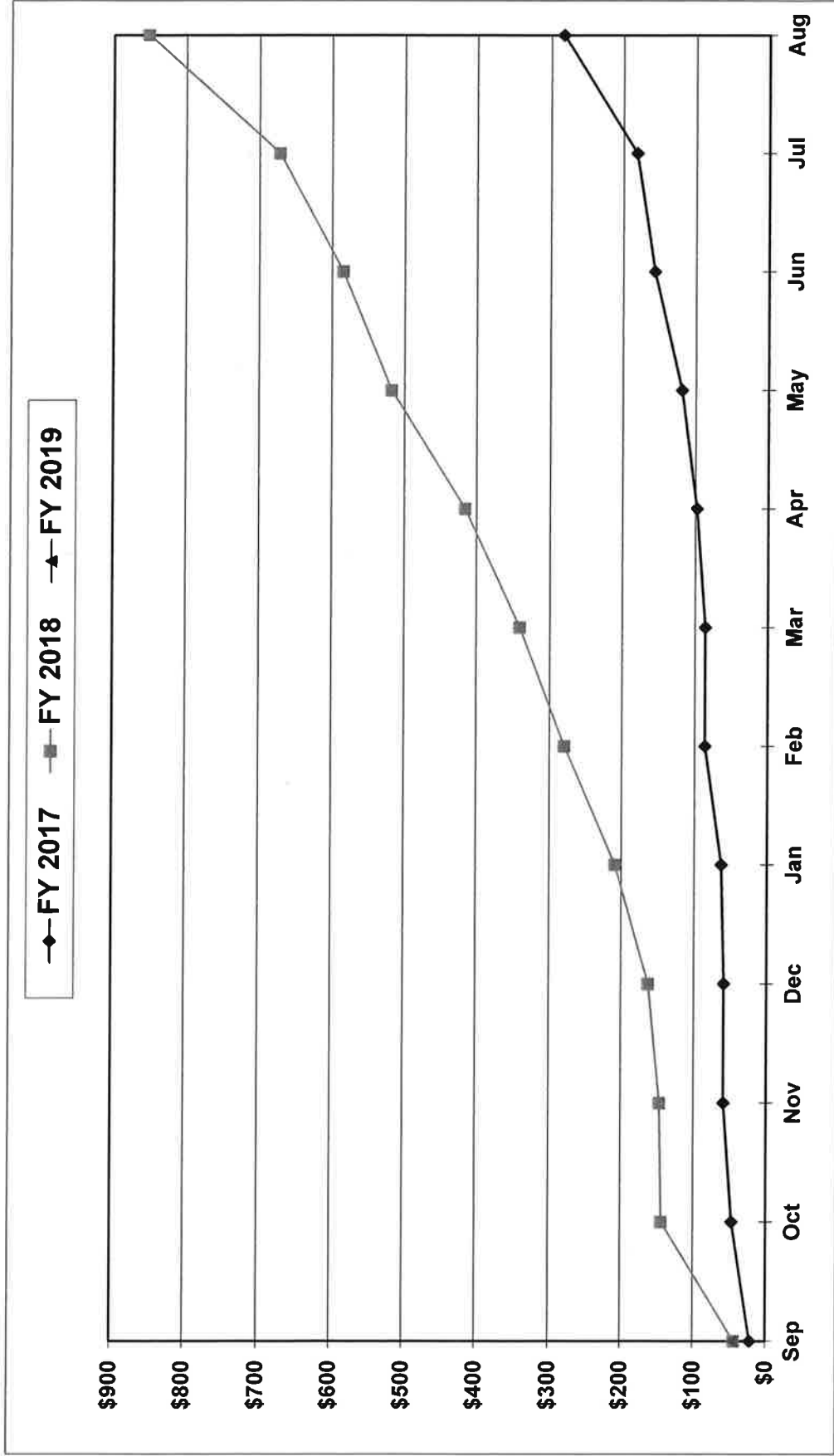
