APPLICATION OF WPX ENERGY PERMIAN, LLC (942623) FOR AN EXCEPTION TO STATEWIDE RULE 32 FOR VARIOUS FLARE POINTS IN THE SANDBAR (BONE SPRING) FIELD, LOVING AND REEVES COUNTIES, TEXAS

ORDER NUNC PRO TUNC

Notice of Open Meeting to consider this Order was duly posted with the Secretary of State within the time period provided by law pursuant to Tex. Gov't Code Ann. Chap, *et seq.* (Vernon 2004 & Supp. 2010). The Railroad Commission of Texas finds that, due to a clerical error, the Final Order entered on October 31, 2018, contained the erroneous use of the word "casinghead" in describing the type of gas to be flared. The correct reference should have read, "WPX Energy Permian, LLC is granted an exception to Statewide Rule 32 (§3.32) for various flare points in the Sandbar (Bone Spring) Field, Loving and Reeves Counties, Texas. WPX Energy Permian, LLC is granted permission to flare gas for up to 2 years from October 12, 2018 to October 12, 2020, for the flare points and volume rates listed in Attachment A."

Accordingly, it is **ORDERED** that the ordering provision in the Final Order and in the Examiners' Report and Recommendation issued in this proceeding is hereby amended *nunc pro tunc* to reflect that:

The Commission hereby adopts the following corrected ordering provision, as follows:

WPX ENERGY PERMIAN, LLC IS GRANTED AN EXCEPTION TO STATEWIDE RULE 32 (§3.32) FOR VARIOUS FLARE POINTS IN THE SANDBAR (BONE SPRING) FIELD, LOVING AND REEVES COUNTIES, TEXAS. WPX ENERGY PERMIAN, LLC IS GRANTED PERMISSION TO FLARE GAS FOR UP TO 2 YEARS FROM OCTOBER 12, 2018 TO OCTOBER 12, 2020, FOR THE FLARE POINTS AND VOLUME RATES LISTED IN THE ATTACHMENT A.

It is further **ORDERED** by the Commission that this order shall be final and effective on the date the order is entered.
