FINAL ORDER NUNC PRO TUNC

On December 11, 2018, one Final Order for the above-referenced cases was signed by the Commission. The Final Order inadvertently references the incorrect lease number for the subject lease of Oil & Gas Docket No. 7B-0309930. The correct lease number is 08233. The Final Order refers to the incorrect number of 02833. For these reasons, the Commission's Final Order in this case is hereby revised, nunc pro tunc, to correct this lease number and reads in its entirety as follows:

The Railroad Commission of Texas ("Commission") finds that after statutory notice in the above-docketed cases, heard on September 4, 2018, the presiding Administrative Law Judge and Technical Examiner have made and filed a Proposal for Decision containing findings of fact and conclusions of law, which was served on all parties of record, and that this proceeding was duly submitted to the Railroad Commission of Texas at a conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the Proposal for Decision and the findings of fact and conclusions of law, and any exceptions and replies, adopts as its own the findings of fact and conclusions of law contained therein, and incorporates those findings of fact and conclusions of law as if fully set out and separately stated herein.

It is **ORDERED** that George Christian's request in his complaint that the Commission find Chan West Oil Corporation ("Chan West") does not have a good faith claim to operate the six wells ("Wells") in the subject leases ("Leases") in Haskell County is **GRANTED**; the Leases include:

1. The Taylor, L.F. (02160) Lease in the Sojourner (Bursen) Field,
2. The Taylor, L.F. (13029) Lease in the Sojourner (Strawn) Field, and
3. The Sojourner (08233) Lease in the Sojourner Field.

Chan West is **ORDERED**, within 30 days from the date this order becomes final, to plug the Wells and place the Leases in compliance with Statewide Rules 8, 14, 15 and any other applicable Commission rules.

It is further **ORDERED** by the Commission that this order shall not be final and effective until 25 days after the Commission's Order is signed, unless the time for filing a motion for rehearing has been extended under Tex. Gov't Code § 2001.142, by agreement under Tex. Gov't Code § 2001.147, or by written Commission Order issued pursuant to Tex. Gov't Code § 2001.146(e). If a timely motion for rehearing of an application is filed by any party at interest, this order shall not become final and effective until such motion is overruled, or if such motion is granted, this order shall be subject to further action by the Commission. Pursuant to Tex. Gov't Code § 2001.146(e) and 16 Tex. Admin. Code § 1.128(e), the time allotted for Commission action on a motion for rehearing in this case prior to its being overruled by operation of law is hereby extended until 100 days from the date the Commission Order is signed.

Each exception to the Proposal for Decision not expressly granted is overruled. All requested findings of fact and conclusions of law which are not expressly adopted are denied. All pending motions and requests for relief not previously granted or granted herein are denied.
