ORDER NUNC PRO TUNC FINAL ORDER DESIGNATING UNCONVENTIONAL FRACTURE TREATED FIELDS

In conference at its office in Austin, Texas, the Railroad Commission of Texas took up for consideration its Final Order entered on March 26, 2019, the matter designating the Lin (Wolfcamp) field as an Unconventional Fracture Treated (UFT) field. The Commission finds that, due to a typographical error, the Unprotested Master Order entered March 26, 2019 incorrectly stated the field designation.

Accordingly, it is ORDERED that the Final Order in Oil and Gas Docket No. 7C-0317412 be, and the same is hereby, amended nunc pro tunc so that the order contains the correct field being designated as UFT and the order now reads as follows:

The Commission finds that after notice and an opportunity for hearing regarding the captioned matter, no operator in the field covered by this order has filed a timely notice of protest or requested a hearing regarding the proposed designation of the Lin (Wolfcamp) Field (No. 53613750) as an Unconventional Fracture Treated ("UFT") Field. This matter having been duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas, the Commission makes the following finding of facts and conclusions of law.

FINDINGS OF FACT

- 1. The Lin (Wolfcamp) field (Field No. 53613750) is an existing oil, gas or oil and gas field recognized, assigned an identification number, and regulated by the Railroad Commission of Texas.
- 2. Sable Permian Resources Land, LLC has proposed to designate the Lin (Wolfcamp) Field as an UFT Field under the provisions of Statewide Rule 86(i) [16 Texas Administrative Code §3.86(i)].
- 3. Notice of the proposed designation was sent by U.S. mail to all operators of record in the Lin (Wolfcamp) Field on February 11, 2019.

- 4. No protest or request for hearing regarding the proposed designation of the Lin (Wolfcamp) Field as UFT Field was received within 21 days of the date the notice was mailed.
- 5. The Lin (Wolfcamp) Field has at least one distinct producible interval within the field with an *in situ* permeability of is 0.1 millidarcies or less prior to hydraulic fracture treatment, as determined by core data or other supporting data and analysis.
- 6. In the Lin (Wolfcamp) Field, as to the completed producing wells for which the Commission issued the initial drilling permit on or after February 1, 2012, either:
 - (a) there are at least five such wells of which at least 65% were drilled horizontally and completed using hydraulic fracture treatment; or
 - (b) there are at least twenty-five such wells drilled horizontally and completed using hydraulic fracture treatment
- 7. Designation of the Lin (Wolfcamp) Field as UFT Field is authorized by Statewide rule 86(i) and will further the orderly and efficient development of the state's hydrocarbon resources.

CONCLUSIONS OF LAW

- 1. The subject matter of this docket is within the jurisdiction of the Railroad Commission of Texas pursuant to Tex. Nat. Res. Code §81.051.
- 2. Legally sufficient notice has been provided to all affected persons pursuant to 16 Texas Administrative Code §3.86(i).
- 3. Designation of the Lin (Wolfcamp) Field as UFT Field will prevent waste and protect correlative rights.

IT IS ACCORDINGLY ORDERED that the Lin (Wolfcamp) Field (No. 53613750) is designated as an Unconventional Fracture Treated Field pursuant to the provisions of Statewide Rule 86.

It is further ORDERED by the Commission that this order shall not be final and effective until 25 days after it is signed. If a timely motion for rehearing is filed by any party at interest, this order shall not become final and effective until such motion is overruled, or if such motion is granted, this order shall be subject to further action by the Commission. Pursuant to Tex. Gov't. Code § 2001.146, the time allotted for Commission action on a motion for rehearing in this case prior to its being overruled by operation of law, is hereby extended until 100 days from the date the parties are notified of the order.
