THE APPLICATION OF PARSLEY ENERGY OPERATIONS, LLC (642652) TO CONSOLIDATE THE BLALOCK (WOLFCAMP), BLALOCK LAKE, E (WOLFCAMP), BLALOCK LAKE, SE (WOLFCAMP), DAI (WOLFCAMP), DEWEY LAKE, S (WOLFCAMP), IVA LEE (CLEARFORK), LENORAH, WEST (DEAN), POWELL (8300), POWELL, N (WOLFCAMP), AND WOULD HAVE (CLEARFORK) FIELDS INTO THE SPRABERRY (TREND AREA) FIELD, VARIOUS COUNTIES, TEXAS.

FINAL ORDER

The Railroad Commission of Texas ("Commission") finds that after statutory notice in the above-numbered docket on the application made by Parsley Energy Operations, LLC (Operator No. 642652) ("Parsley") heard on October 2, 2019, the Technical Examiner and Administrative Law Judge have made and filed a report and recommendation ("Report") containing findings of fact and conclusions of law, for which service was not required; that the proposed application complies with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas.

The Commission, after consideration of this matter, hereby adopts as its own the findings of fact and conclusions of law contained in the Report and incorporates those findings of fact and conclusions of law as if fully set out and separately stated herein.

Therefore, it is ORDERED by the Commission that the BLALOCK (WOLFCAMP), BLALOCK LAKE, E (WOLFCAMP), BLALOCK LAKE, SE (WOLFCAMP), DAI (WOLFCAMP), DEWEY LAKE, S (WOLFCAMP), IVA LEE (CLEARFORK), LENORAH, WEST (DEAN), POWELL (8300), POWELL, N (WOLFCAMP), and WOULD HAVE (CLEARFORK) be consolidated into the SPRABERRY (TREND AREA) FIELD (ID NO. 85280300).

It is further ORDERED by the Commission that wells in the BLALOCK (WOLFCAMP), BLALOCK LAKE, E (WOLFCAMP), BLALOCK LAKE ,SE (WOLFCAMP), DAI (WOLFCAMP), DEWEY LAKE, S (WOLFCAMP), IVA LEE (CLEARFORK), LENORAH, WEST (DEAN), POWELL (8300), POWELL, N (WOLFCAMP), and WOULD HAVE (CLEARFORK) be transferred into the SPRABERRY (TREND AREA) FIELD (ID NO. 85280300).

It is further **ORDERED** by the Commission that all wells subject to this field consolidation order shall be validly permitted wells in the Spraberry (Trend Area) Field without the need for a new drilling permit. Operators of such wells are not required to apply for new drilling permits in the Spraberry (Trend Area) Field. If the locations of such

wells do not comply with the spacing or density rules of Spraberry (Trend Area) Field they will nevertheless be transferred into the Spraberry (Trend Area) Field by this field consolidation order without need for new drilling permit applications or spacing or density exceptions to the rules of the Spraberry (Trend Area) Field.

It is further **ORDERED** by the Commission that a Form P-4, Producer's Transportation Authority and Certificate of Compliance, is required to be filed for all leases in the prior existing fields to change the field name to the Spraberry (Trend Area) Field. New lease numbers will be assigned if the operator does not already have an existing lease number assigned in the Spraberry (Trend Area) Field. A Form P-16, Acreage Designation, and full lease plats are also required in the new field and should be sent to the Commission with the Form P-4 if acres are not already assigned to the operator's wells that meet the new field criteria. Operators must respond within sixty (60) days of this order's final and effective date.

Pursuant to § 2001.144(a)(4)(A), of the Texas Government Code, and by agreement of the parties in writing or on the record, the parties have waived right to file a Motion for Rehearing and this Final Order is final and effective on the date the Master Order relating to the Final Order is signed.
