A Contract Shipper must notify Carrier in writing of any Designated Shipper that will be shipping on the Contract Shipper's behalf.

RECEIPTS FROM TANK TRUCKS: Pursuant to Rule 110 of the Rules and Regulations Tariff, shipments unloaded from tank trucks Badger Terminal at Alpha Wink 302, Winkler County, Texas will be subject to charge of **[U]** 21.0 cents per barrel.

H2S TREATMENT: If Crude Petroleum received by Carrier contains a level of hydrogen sulfide ("H2S") that exceeds the H2S specification of connecting carriers at the destination points contained herein, Carrier reserves the right to treat such crude to ensure that it conforms to H2S specifications of connecting carriers. If Carrier performs such treatment, Carrier reserves the right to bill and Shipper shall pay the costs incurred by Carrier as a result of such treatment or removal of H2S.

Exceptions to [W] Felix Midstream, FM Gathering LLC's Rules and Regulations Tariff:

Rules 25(c) and 25(d) - In lieu of the nomination due date contained in Rules 25(c) and 25(d) of [W] Felix Midstream, FM Gathering LLC's Rules and Regulations Tariff, the following will apply: nominations to the Carrier shall be made before 12:00 noon Central Standard Time/Central Daylight Saving Time, whichever is applicable, on the fifteenth (15th) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rules 25(c) and 25(d).

Rule 40 - In lieu of the API Gravity specified in Rule 40 of the Rules and Regulations Tariff, the following will apply: API gravity shall not exceed 84.9°.

Rule 80D – For service under the Contract Rates contained herein, in lieu of the Allowance Oil percentage set forth in Rule 80D of the Rules and Regulations tariff, the following will apply: a deduction of one-tenth of one percent (0.1%) will be made to cover evaporation, interface losses, and other normal losses during transportation.

Rule 80E - In lieu of the table for deduction to cover shrinkage and evaporation set forth in Rule 80E of the Rules and Regulations Tariff, the following will apply: the deduction for incremental evaporation and shrinkage shall be determined in accordance with the following table:

60.0 through 74.9	5.0%
75.0 and above	10.0%
