

**AMENDMENT NO. 2
MASTER SERVICE AGREEMENT
CONTRACT NO. 455-18-8656 FOR
ANALYTICAL SERVICES FOR SITE REMEDIATION – STATEWIDE
BETWEEN
THE RAILROAD COMMISSION OF TEXAS
AND
TESTAMERICA LABORATORIES, INC.**

THIS AMENDMENT NO. 2 is entered into by and between the Railroad Commission of Texas (“RRC”), a state agency located at 1701 N. Congress Ave., Austin, Texas and TestAmerica Laboratories, Inc. (“Contractor”), located at 1733 North Padre Island Drive, Corpus Christi, Texas (collectively, the “Parties”) to amend the Contract between the Parties (“Contract”).

WHEREAS, SECTION 7.07. of the Contract provides the Parties may amend the Contract through written agreement; and

WHEREAS, on August 30, 2018, the Parties executed **Amendment No. 1** to the Contract modifying subsection **2.01. CONTRACT AWARD.**, subparagraph (a.) to continue the Contract through August 31, 2020, through exercise of renewal option 1 of 2 and modifying subsection **3.01. CONTRACT LIMIT AND FEES AND EXPENSES.**, to change the not-to-exceed total amount of the Contract from NINETY-FIVE THOUSAND DOLLARS AND NO CENTS (\$95,000.00) to ONE HUNDRED TWENTY-FIVE THOUSAND DOLLARS AND NO CENTS (\$125,000.00) through the end of the first renewal term of the Contract, as approved by RRC Commissioners on August 6, 2019.

WHEREAS, the Parties desire to amend the Contract terms to their mutual benefit to reflect the changed circumstances.

NOW, THEREFORE, the Parties agree to amend the Contract as follows:

I. SECTION 2.01. CONTRACT AWARD., subparagraph (a.) is deleted in its entirety and replaced with the following:

This Contract shall be effective as of the date executed by the Parties and shall continue through August 31, 2021 (the second of two total optional renewal terms) unless extended by the Parties by amendment to this Contract or terminated earlier, as provided in Section **2.02. TERMINATION.**


II. SECTION 3.01. CONTRACT LIMIT AND FEES AND EXPENSES., the paragraph is deleted in its entirety and replaced with the following:

The total amount of fees to be paid under this Contract through the end of term must not exceed ONE HUNDRED THIRTY-SIX THOUSAND, TWO HUNDRED FIFTY DOLLARS AND NO CENTS (\$136,250.00), the total of which includes the addition of ELEVEN THOUSAND, TWO HUNDRED FIFTY DOLLARS AND NO CENTS (\$11,250.00) for the term of the Contract.

Except as expressly amended above, all provisions of the Contract remain in full force and effect.





