ORDER DENYING MOTIONS FOR REHEARING

Notice of an open meeting to consider this Order was duly posted with the Secretary of State within the time provided by law pursuant to Tex. Gov't Code Chapter 551.

On August 21, 2020, Administrative Law Judge Dee Marlo Chico issued an interim ruling Granting DCP Guadalupe Pipeline, LLC's Motion to Dismiss (Hearings Letter No. 8). Also, on August 21, 2020, the Hearings Director issued an Order of Dismissal (Hearings Letter No. 9).

On August 28, 2020, Atmos Energy Corporation ("Atmos") filed an *Interim Appeal to Stay and Reverse Hearings Letter Nos. 8 and 9 or, in the Alternative, Motion for Rehearing of Hearing Letter No. 9, and Request for Oral Argument*. DCP Guadalupe Pipeline, LLC ("DCP") filed a *Response to Atmos's Interim Appeal to Hearings Letter Nos 8 and 9* on September 8, 2020. Atmos's Interim Appeal was denied by operation of law on September 10. On October 5, 2020, Atmos filed a *Motion for Rehearing of Hearings Letter No. 8, Order Granting DCP's Motion to Dismiss*. On October 19, 2020, DCP filed a *Response to Atmos Energy Corporation's October 5th Filing Styled as a Motion for Rehearing of Hearings Letter No. 8*.

On August 28, 2020, Atmos filed a Motion for Rehearing to the Hearings Director's Dismissal Order—the *Interim Appeal to Stay and Reverse Hearings Letter Nos. 8 and 9 or, in the Alternative, Motion for Rehearing of Hearing Letter No. 9, and Request for Oral Argument*. On September 30, 2020, DCP filed a *Response to Atmos Energy Corporation's Motion for Rehearing of Hearings Letter No. 9*.

The Commission finds Atmos's motions do not raise significant issues of fact or law not previously considered by the Commission.

Therefore, **IT IS ORDERED** that the Atmos's Motions for Rehearing are **DENIED**.
